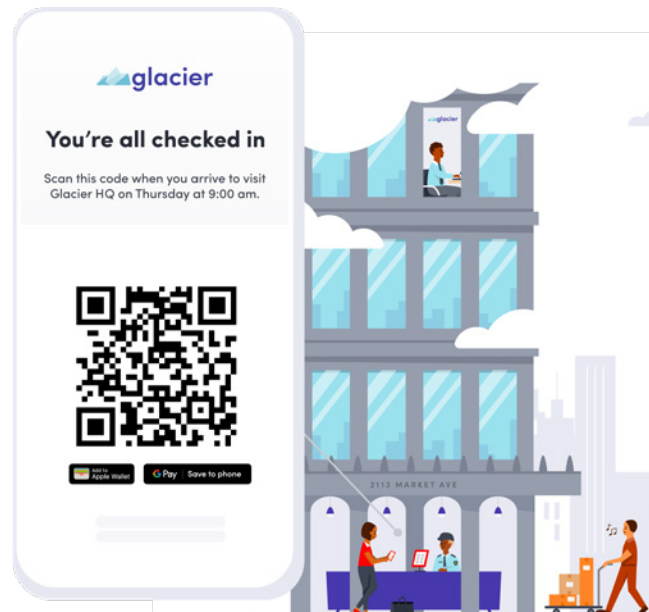

Customizable sign-in

Create multiple check-in flows that ask different questions based on the reason for the guest's visit.



Emergency notifications

Alert people onsite with automatic notifications sent via frequently used channels like SMS, Slack, Microsoft Teams, or email.



Virtual reception sign-in

Allow guests to scan a printed QR code and complete the required sign-in steps on their mobile device.



Identity verification

Make sure visitors are who they say they are by scanning IDs and cross-checking against internal blocklists and third-party watchlists.



Multi-location invites

Let approved guests securely access multiple buildings at your sites with a single email or QR code.



Visitor log

Automatically maintain detailed, up-to-date visitor records to ensure compliance with audit requirements. Export data in a few clicks.



Occupancy analytics

View comprehensive visitor data and automatically share custom reports with stakeholders on a set schedule.



Flexible access
